

## **"SUSTAINABLE OCEANS STUDENT COMPETITION AUSTRALIA"**

### **TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents who are current high school students in Australia (either in person or home learners). Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
3. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

(b) Complete each lesson on Sustainable Oceans and answer each multiple choice and short answer question.

For students that are **not** subscribed to Education Perfect:

(a) After registration, create a competition account on the Education Perfect platform;

(b) Access the Education Perfect Learning Platform and follow the prompts to the competition tab;

(c) Complete each lesson on Sustainable Oceans and answer each multiple choice and short answer question.

7. Each time an entrant provides one (1) correct answer in the Sustainable Oceans lessons and based on the points guidelines, the entrant will receive one (1) point. For clarity, extended response questions are excluded for the purposes of this promotion.
8. The top one thousand (1,000) students that have accumulated the most points during the Promotional Period will be entered into the draw. In the event of a tie for points between students meaning that several students will be ranked equal-1,000th, all the students ranked equal -1,000th will be entered into the draw.
9. Multiple entries permitted, subject to the following:
  - (a) there are nine (9) lessons on Sustainable Oceans and each lesson may be completed by each student multiple times (including multiple times in one (1) day), however a student can only accumulate the points on each correct question one (1) time a day and up to two (2) times per question during the competition period.
  - (b) each entry submission (via the completion of a lesson) must be submitted separately and in accordance with entry requirements.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
